#### FIRST AID

## GENERAL INFORMATION

BLUE MARKER DYE is a flexible, user-friendly, safe colorant for applications of liquid pesticides and fertilizers. BLUE MARKER DYE indicates to the applicator where a spray has already been made. BLUE MARKER DYE aids in reducing cost, by indicating areas that have not been sprayed, which helps to avoid overspray.

BLUE MARKER DYE is a temporary colorant that fades in a few days. BLUE MARKER DYE is compatible with all pesticides and fertilizers, and will not have an effect on their efficacy.

## SUGGESTED USE RATES

Shake Well Before Using.

BLUE MARKER DYE application rates will differ depending on foliage color and height and spray application rates. For best results, test the quantity of spray solution and rate of BLUE MARKER DYE to determine a rate that is practical.

**SUGGESTED RATES:** 16 to 24 ounces per 100 gallons (500 - 750 mL per 400 liters) of spray solution. For backpacks and small sprayers, use 2-3 ounces per 3 gallons (60 - 90 mL per 12 liters).

## STORAGE AND DISPOSAL

**Storage:** Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

**Disposal:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
