### FIRST AID

**EYE CONTACT - IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do then continue rinsing. Have the product container with you when calling a poison control center or doctor, or going for treatment. If eye irritation persists: Get medical advice or attention.

**SKIN CONTACT - IF ON SKIN (hair) OR CLOTHING:** Remove/take off immediately all contaminated clothing. Rinse skin with water/shower. Take off contaminated clothing and wash it before reuse. Call a poison center, doctor, chemical manufacturer, importer, or distributor to specify the appropriate source of emergency medical advice.

### INGESTION - IF SWALLOWED:

Immediately call a POISON CENTER or doctor/physician. Unless advised otherwise by a poison control center or doctor, have person rinse mouth with water, if able. Do not give anything by mouth to an unconscious person. Do NOT induce vomiting.

**INHALATION - IF INHALED:** If breathing is difficult, remove person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

## GENERAL INFORMATION

DIAMOND-R TANK CLEANER is a premium-grade, spray tank cleaner, that will clean, rinse and emulsify pesticide and adjuvant residues and bond them to the rinse solution to allow for complete cleaning and system purging with ordinary water. DIAMOND-R TANK CLEANER is hard-water tolerant which minimizes the tendency of spray tanks to accumulate high levels of residue. DIAMOND-R TANK CLEANER is soluble and compatible with all spray tank materials. DIAMOND-R TANK CLEANER neutralizes acid residues of pesticides, preparing the spray tank for the use of other products. Neutralization of residue spray materials will prevent damage from occurring on non-target plants.

## DIRECTIONS FOR USE

**LARGE VOLUME SPRAYERS:** DIAMOND-R TANK CLEANER is effective at dilution rates up to 1:400. One quart (.95 L) of DIAMOND-R TANK CLEANER will treat up to 100 gallons of water. One gallon (3.78 L) will treat up to 400 gallons. Adjust the dilution rate as needed for individual conditions. Each cleaning situation will vary and adjustments will be necessary. Be certain to circulate DIAMOND-R TANK CLEANER treated solution through the spray system for 5-10 minutes. Use a high-pressure sprayer or hose to rinse all interior areas and spray tank walls. Purge hoses, spray lines and nozzles for approximately one minute. After cleaning, drain system and rinse all tank and spray areas.

**HAND-HELD AND BACK-PACK SPRAYERS:** Use approximately one ounce of DIAMOND-R TANK CLEANER per gallon of water, agitate thoroughly, drain and repeat with a clean water rinse.

**NOTE:** The use of DIAMOND-R TANK CLEANER or other Tank Cleaners does not guarantee removal and/or neutralization of all residues. Some pesticides, such as 2,4-D and Dicamba, may leave persistent or hard-to-remove residues. Many variables exist which make consistent tank cleaning difficult (i.e., water quality, use of cleaning equipment, quantity and type of residue, age and condition of spray tank, spray lines, nozzles etc.). In order to ensure that all residues have been removed, apply a sample of the rinse water to sensitive plants (tomato, cotton, ornamentals, etc.) and after sufficient time, observe for wilting or severe stress. If stress occurs, repeat cleaning process and retest as above.

## STORAGE AND DISPOSAL

**STORAGE:** Store locked up. Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

**DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
